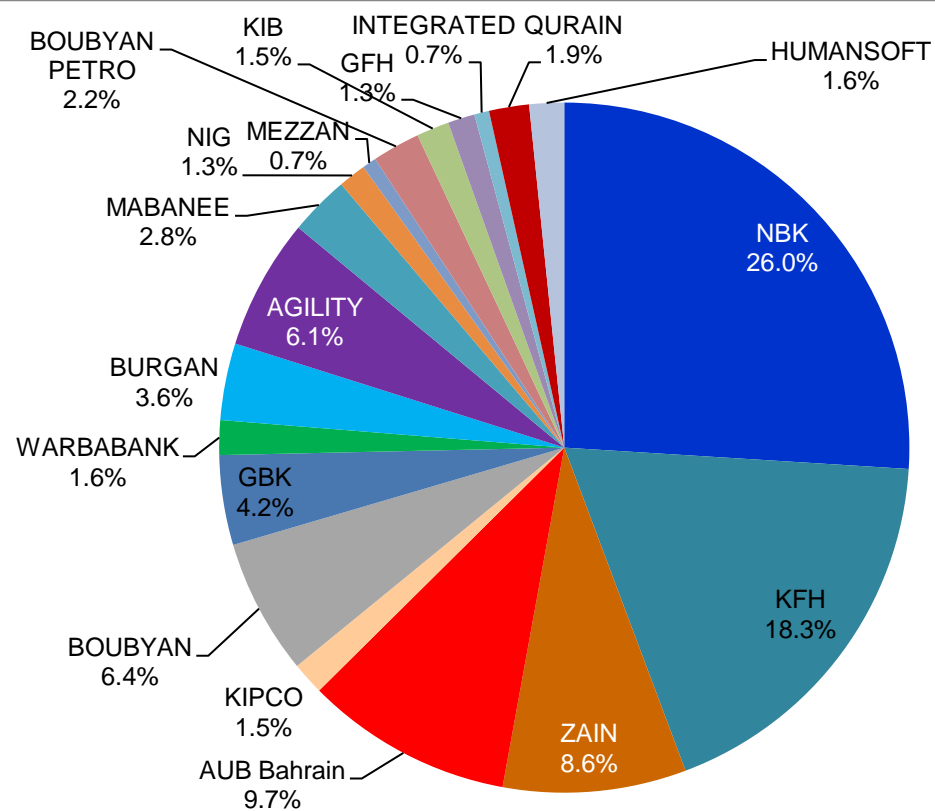

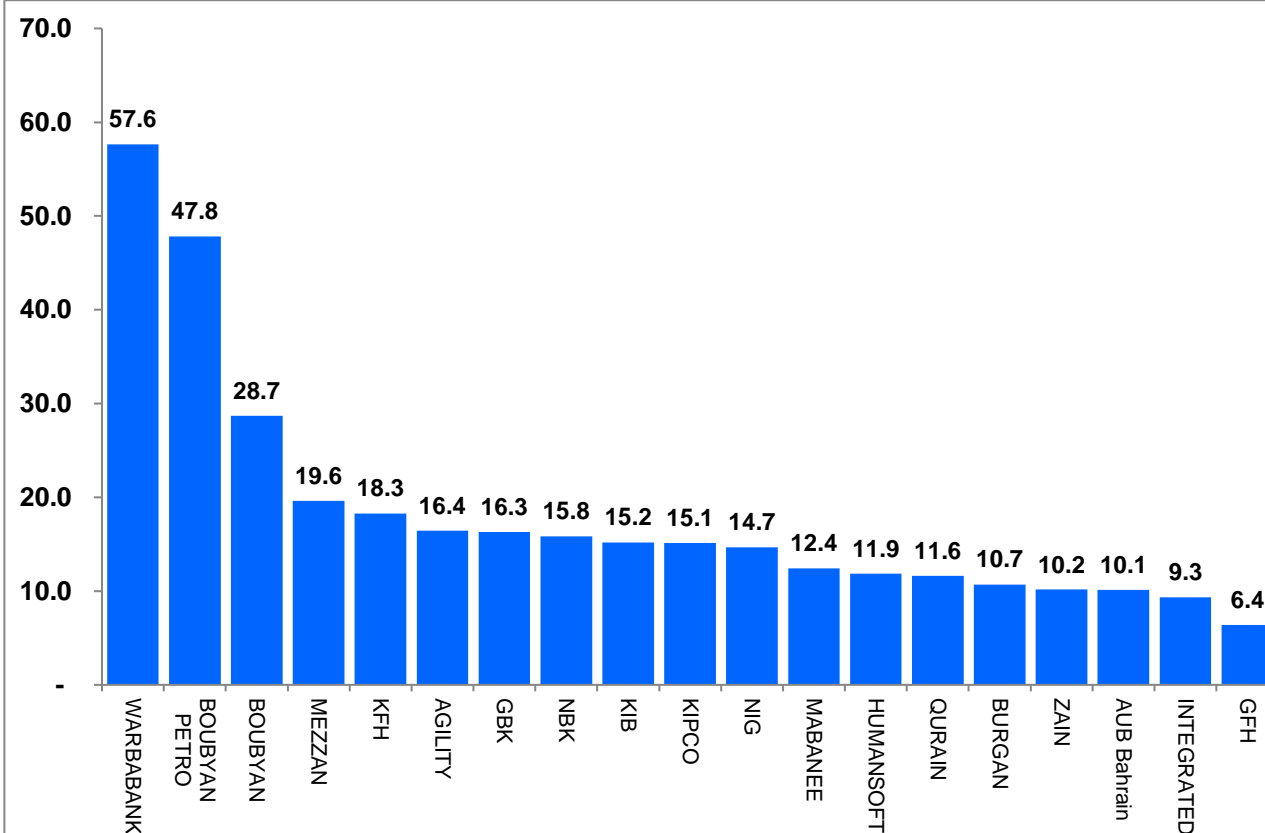

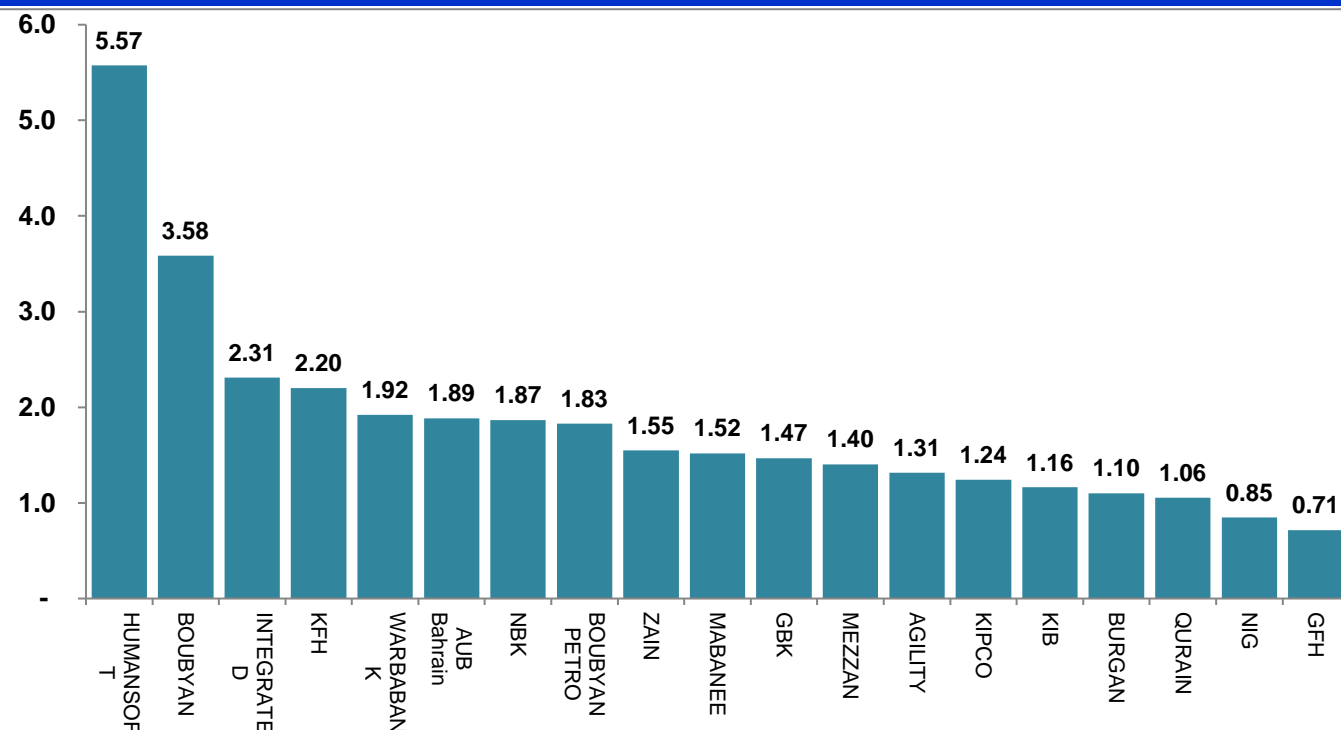
### Premier Market Components' Weight



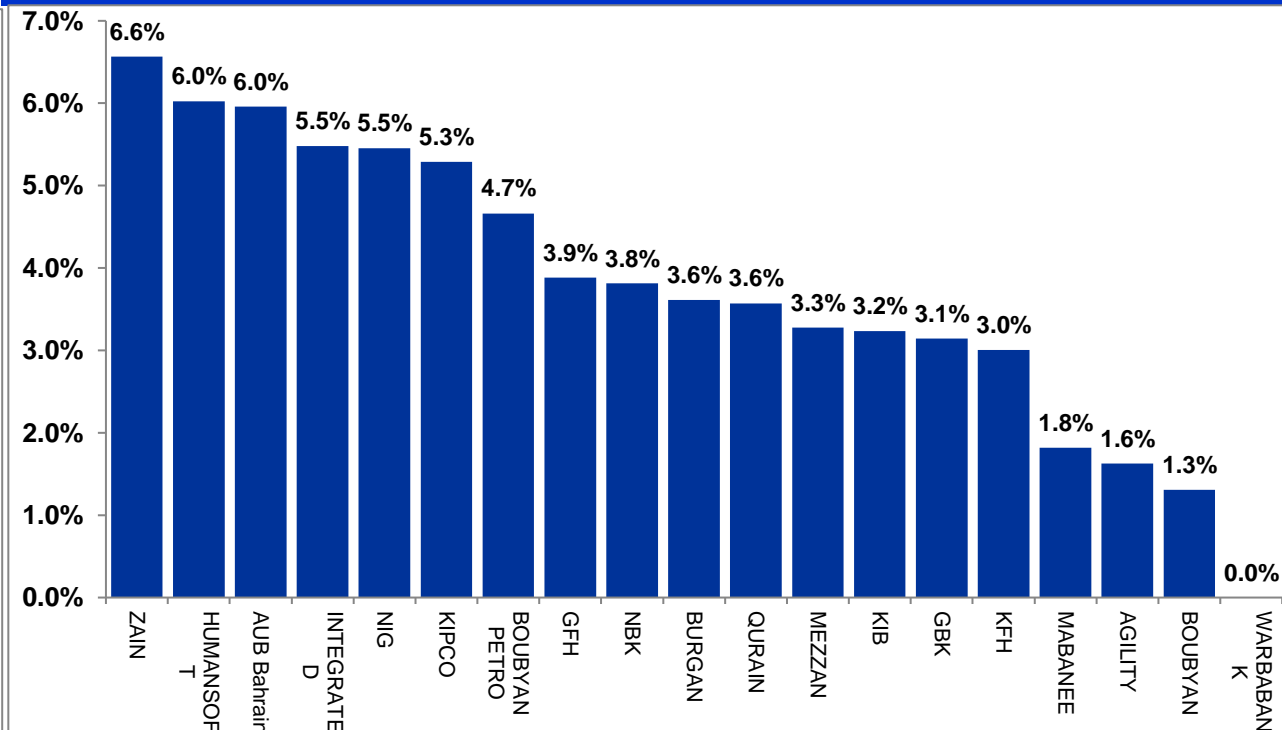
### Premier Market Stocks' Price to Earnings Ratio (P/E)



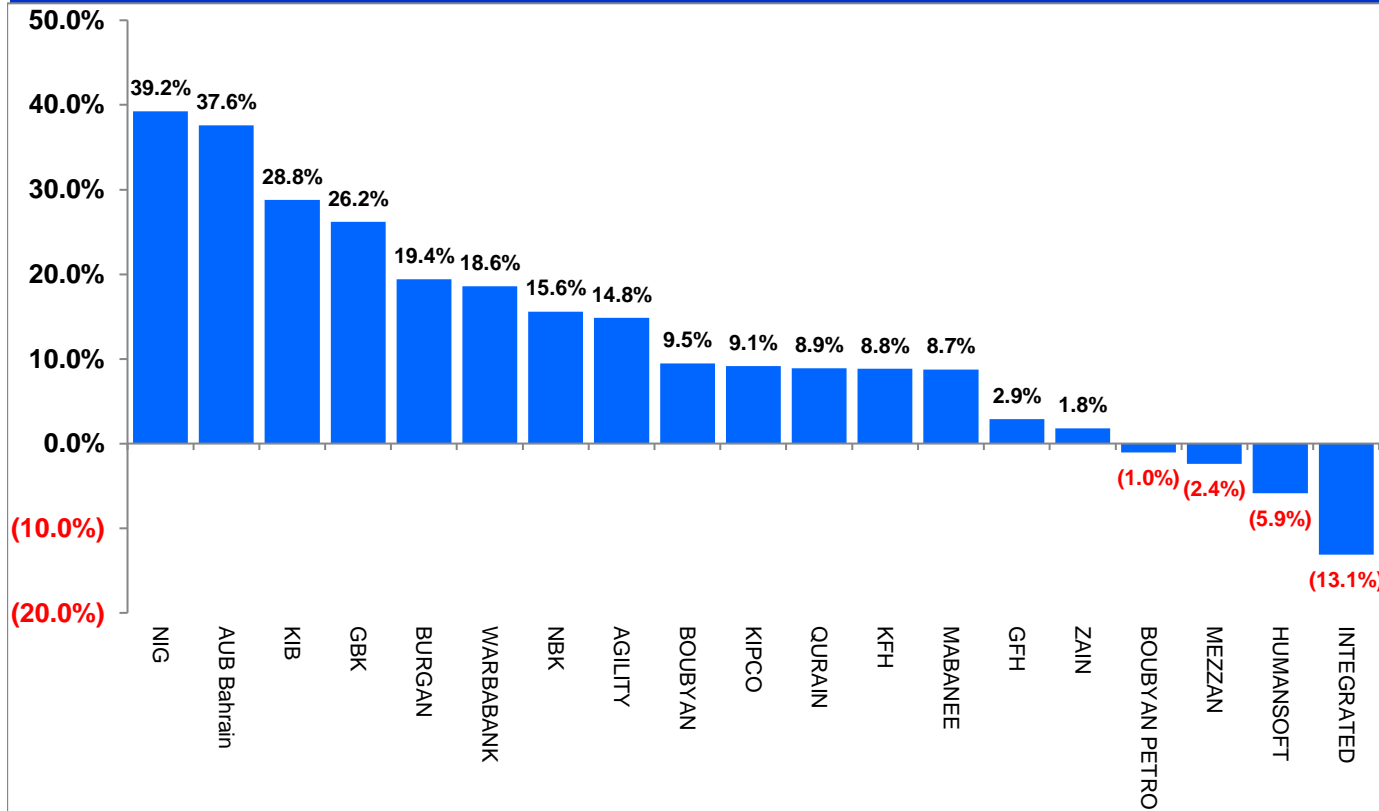
### Premier Market Stocks' Price to Book Value Ratio (P/BV)



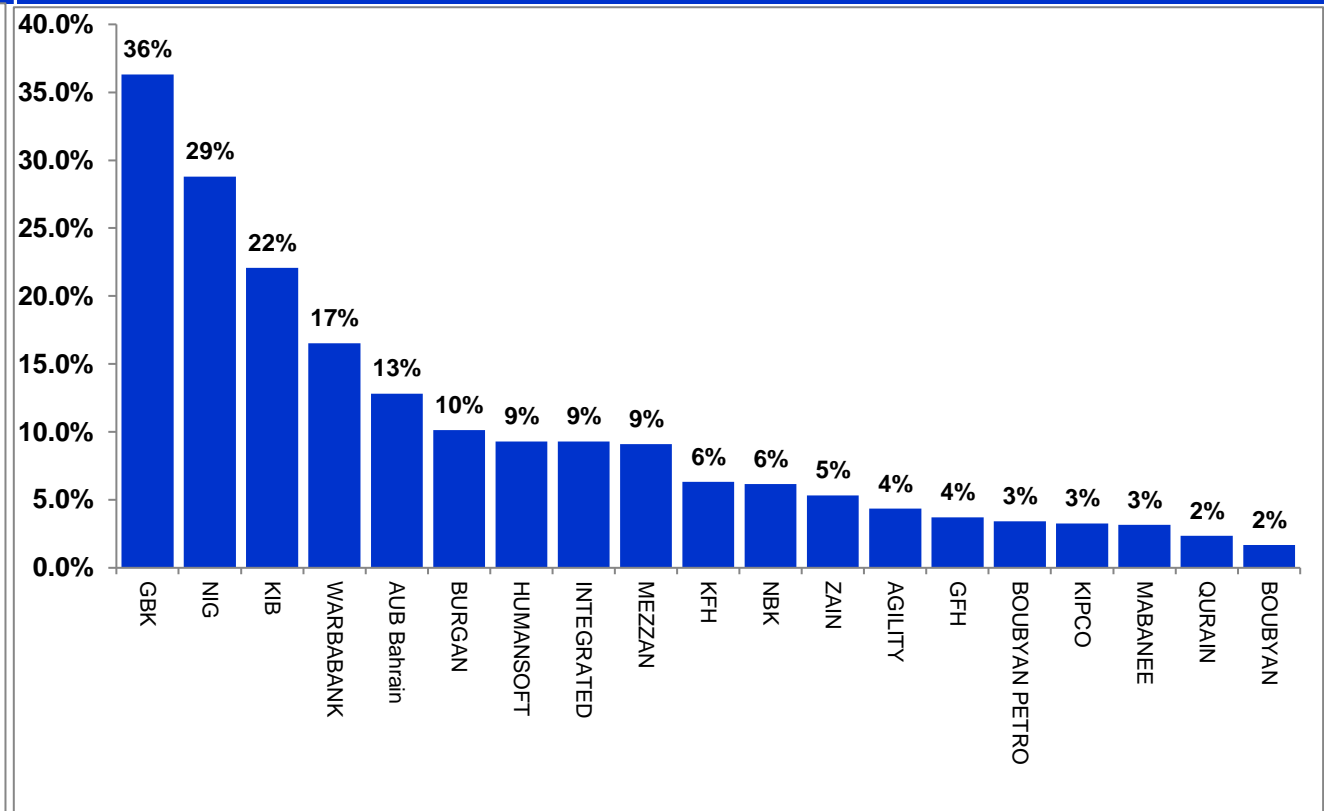
### Premier Market Stocks' Ranking By 2018 Dividend Yield
